



Official Rules & Acknowledgement

1. Entrants will be responsible for providing their own equipment, costumes, music and any other special tools needed to perform their chosen act.
2. At least one member of each act will need to be an HTIFCU member. Also, participants will be required to purchase tickets to attend the Annual Dinner.
3. No payment or reimbursement will be made to entrants for any items purchased for their act.
4. Prizes: Grand Prize winner will receive \$500 cash. Prizes are non-transferable and may not be exchanged. Winners will be responsible for reporting winnings to the IRS.
5. Professionals are ineligible. A professional is considered to be anyone who makes a living off of performing, or who advertises themselves as an entertainer available for hire.
6. Entrants will receive a total of five (5) minutes for their performance. Entrants may not exceed the allotted amount of time, or may face disqualification.
7. Entrants will also receive five (5) minutes total to set-up and take-down their equipment before and after their performance.
8. No practice-time will be allotted for entrants during the show. Entrants will be responsible for arranging time for their own practices and rehearsals.
9. Talent show entrants using specific music, audio or video will need to submit their accompanying video/audio at least **15 days** prior to the talent show (held on Saturday, April 21, 2018).
10. If we exceed the maximum number of sign-ups for the talent show, then we may require entrants to submit a recording of their act for review. If no recording can be provided, act may be able to perform the act in person as a substitution. If audition is necessary, entrants will be contacted via information provided on entry form.
11. No profanity or vulgarity will be allowed in performances. Profanity includes, but is not limited to: foul or discriminatory language, hand gestures, body movements, facial expressions, etc.

I have read and agree to uphold the Official Rules of this talent show. If I fail to follow these rules, I may face disqualification from the show, and will become ineligible to receive a prize.
